Anson City Council Meeting

The Anson City Council met on the 11th day of January 2016 at the Anson Public Library. Members of the Council present were Keith Gilbert, Evelyn Edwards, Angela Ramirez, Jeannie Free, and Larry White. Also present City Attorney Chad Cowan, Police Chief David Moore, and City Manager Sonny Campbell.

With Mayor Herndon being absent Mayor Pro-tem Keith Gilbert called the meeting to order at 5:59pm.

Larry White provided the opening prayer.

A. Discuss and take action on minutes from previous meeting.

Evelyn Edwards made the motion to approve the minutes with 3 corrections, Angela Ramirez provided the second all approved.

B. Presentation from Citizens. No formal action may be taken.

Pat Seballos addressed the council with concerns about 2311 Ave N street maintenance, and concerns with the Anson City Pool Mushroom fountain.

C. Discuss and take action on sale of trust property known as Lot Twelve (12) in Block three (3), of Wilson and McCreight Addition in the City of Anson, Jones County, Texas (R16809). For the Bid of \$276.00 from Geneva Dalbert, 1202 Ave. D, Anson Texas 79501

Motion by Evelyn Edwards to accept the bid of \$276.00 from Geneva Dalbert for property R16809, Larry White provided the second all approved.

D. This petition needing signatures from 10% of the registered voters from the last general election. If the 10% of petition signatures is met a ballot item can be placed in the next general election.

Motion by Evelyn Edwards to move forward in the creation of a petition to dissolve the IDC and reallocate monies to street fund, Angela Ramirez provided the Second, all approved.

H. Discussion of Open Meeting Act and Open Records Act training required of all council as set out in Texas Government Code §551.005.

City Attorney Chad Cowan gave the council various examples of the Open Meeting Act and Open Records Act, and also informed the new council members they had 90 days to complete their training. With no action needed the council moved on.

I. Police Report

a. Discuss reports from the previous month pertaining to law enforcement and animal control.
Chief Moore. Provided the council a summary of all police activity and animal control activity for the month of December 2015. With no action needed the council moved on.

J. City Manager Report: Discuss and take action on

City Manager Campbell informed the council that TML will approve Anthony Ramos's claim, and that new claim had been filed on the Cosby home due to a 2nd floor leak that had occurred and caused significant water damage.

b. Update on EMS.

City manager Campbell informed the council that City would exclude the EMS from the asset transfer to the Hospital district. An inspection of the EMS unit is scheduled and upon successful inspection the City will be eligible for a provider number. The City will continue to use the Hospitals provider number until the City's provider number is acquired.


Mayor Pro-tem Keith Gilbert called the Public hearing to order at 5:52pm.

Mayor Herndon called the meeting to order at 6:00pm

Keith Gilbert provided the opening prayer.

A. Discuss and take action on minutes from the previous meeting.

Evelyn Edwards made the motion to approve the minutes, Angela Ramirez provided the second all approved.

B. Presentation from Citizens. No formal action may be taken. (limit 5minutes per spokesperson)

Pat Seballos provided the City Council with an IDC expense report for the previous 5 years, and requested the IDC be provided with an ADC expense report for the previous 10 years.

Linda Powell informed the Council that she would be recording the meeting pertaining to the IDC.

C. Discuss and take action on second reading of an ordinance calling for a special election to reallocate the sales and use taxes for the Industrial Development Corporation of Anson, Inc. (a 4A Economic Development Corporation); the Anson Development Corporation, Inc. (a 4B Economic Development Corporation); and the Street Maintenance and Repair Tax.

After council discussion Keith Gilbert made the motion to approve Ordinance #915 and move forward with the Special Election to reallocate the sales and use taxes, Larry White provided the second. Vote taken with 4 votes of aye and 2 votes of nay (Jeannie Free and Angela Ramirez)

D. Discuss and take action on repair of Road grader.

Jeannie Free made the motion to move forward with the repair of the Model-140H road grader based upon the \$9,477.75 estimate provided by Warren Cat, Larry White proved the second, all approved.

E. Discussion on flooding of the Wilson Trailer parking lot (Ray Wilson)

Ray Wilson not being present Bobby Wilson represented Wilson Trailer. Bobby Wilson provided the council with a map describing the various elevation changes in the Waterway, and his ideas to alleviate the problem flooding. The Council and Mr. Wilson discussed the problems with the water way and potential solutions to improve the flow of water.

K. Discuss and take action on accounts payable.



At 6:29pm the City Council adjourned into Executive Session. Linda Powell, being the IDC President, was asked to remain.

The City Council reconvened in open session at 7:54pm.

Jeannie Free made the motion to pay the IDC accounts payable except the February 3, 2016 and February 17, 2016 Newspaper ads as they advocated against a political action. Keith Gilbert provided the second, all approved.

J. Discuss and take action on Employee Recognition.

Evelyn Edwards addressed the Council with an idea to use each of the City Council member's monthly pay of \$6.00 for a quarterly award for outstanding employee recognition pay. Judge Crawford, City Manager Sonny Campbell, and Police Chief David Moore would not be eligible for the Outstanding Employee recognition pay.

Mayor Herndon suggested that City Manager Sonny Campbell and Evelyn Edwards get together to determine how the Employee of the Quarter will be determined.

Mayor Herndon made the motion to move forward with the plan, Keith Gilbert provided the second all approved.

Anson Special Call City Council Meeting

It is as follows "After consultation with the City Attorney, the Texas Secretary of State, and the Texas Municipal League it has been determined that Ms. Ortega does not meet the residency requirement and is ineligible. The Texas Election Code §145.003(d) states "the presiding officer of the final canvassing authority for the office sought by a candidate may declare the candidate ineligible



after the polls close on election day and before a certificate of election is issued" The presiding officer of the City of Anson is the Mayor and I declare that Terra Ortega is an ineligible candidate. She will not be placed on the ballot for the runoff election. The Texas Election Code §145.005(d) further states that "in a race in which a runoff is required, if the ineligible candidate received the vote that would entitle the candidate to a place on the runoff election ballot, the candidates in the runoff shall be determined in the regular manner but without regard to the votes received by the ineligible candidate." The results of the General Election prior to the declaration of ineligibility was 160 votes Nolan Lindsey, 294 Votes for Robert Patterson, and 250 votes Terra Ortega. That is 704 votes with no candidate receiving a majority of the votes. If you do not count the votes for Ms. Ortega, you have 454 votes between Nolan Lindsey and Robert Patterson, and Mr. Patterson has a majority of those 454 votes."

3. Discuss and take action on canvassing the election results from the November 8, 2016, General Election (2nd Canvassing), if necessary.


