Duties of Mayor: The Mayor of the City shall be the presiding officer of the Council, except that in his absence a Mayor Protempore may be chosen; he shall be entitled to vote as a member of the Council; sign all bonds; be the official head of the city, and exercise all powers and perform all duties imposed upon him by this Charter and by the ordinances of the city.

AMENDED Article V, Section 11.

Duties of Mayor: *Amend the entire text of this section to read as follows:* "Duties of Mayor. The Mayor of the City shall be the presiding officer of the Council and all Council meetings. In his or her absence, a Mayor Pro Tem shall be chosen and shall serve until replaced by another Mayor Pro Tem.
