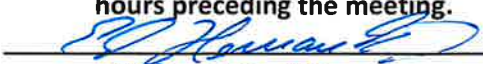

- C. Discuss and take action on an application to amend the zoning map from Dwayne Jones, 1765 US HWY180 W, Anson, TX 79501. The applicant is requesting that approximately 0.3 acres of land described as being out of Survey No. 4, MEP&P RR. Company Lands and being the East 65 feet of lots 11 and 12 and the North 25 by 65 feet off of the East end of Lot No. 10, in Block 186, Johnson Addition to the Town of Anson, Jones County, Texas better known as 1027 17th Street, Anson TX 79501, , formerly known as the Steve Moody gun Shop. be amended from the current C-2 (General Commercial) District Zoning to a MF (Multifamily Dwelling District) Zoning. The applicant would like to transform the former gun shop into a duplex with an entry in front and back and each apartment will have its own air, bathroom, kitchen, etc
